## Fiber One Fall Off Forgiveness Sweepstakes Official Rules

Administrator's computer is the official time-keeping device for the Sweepstakes.

**4. How to Enter:** During the Promotion Period, visit <a href="http://www.FalloffForgiveness.com">http://www.FalloffForgiveness.com</a> ("Website") and follow the links and instructions to complete and submit the registration form including a valid email address, you will receive one (1) Sweepstakes entry into the applicable Weekly Entry Period drawing.

<u>Limit</u>: You may enter one (1) time per day during the Promotion Period, for a total of up to twenty-eight (28) Sweepstakes entries during the Promotion Period. Multiple entrants are not permitted to share the same email address. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
